IMPACT: Protecting Families and Victims of Crime

Stable families form the backbone of a thriving and resilient community. They provide a foundation of **support and security**. The Family Law and Victims of Crime Unit at CCLA provides expert legal representation to victims of crime and domestic abuse. Our **holistic legal approach** representing victims of domestic abuse and crime not only addresses immediate legal needs but additionally **encompasses emotional support, referral to social services, access to other vital legal services and long-term safety planning to empower survivors toward a life free from violence**. When families thrive, they create a ripple effect of resiliency, strengthening the fabric of our community.

Client Impact: CCLA's Holistic Legal Services Support Rosa Through a Difficult Time

Rosa's ex-boyfriend is her son's father and although they shared a home together, their relationship was platonic and for the benefit of their son. One night, Rosa was awakened by her abuser. He was in her room yelling at her. He accused her of having a sexual relationship with another man. He punched her in the face and beat her all over her body, berated her, and threatened her.



The next morning, her abuser left for work. Rosa went to the hospital.

Her eye was bruised and swollen, she had two broken ribs and a punctured lung. The hospital staff called the police for her. The police took pictures of her injuries and a sworn statement. Her abuser was arrested for aggravated battery with great bodily harm.


Rosa filed a Petition for an Injunction for Protection Against Domestic Violence and came to Coast to Coast Legal Aid of South Florida. CCLA represented Rosa at her return hearing and companion paternity case. With the felony criminal charges still pending, the abuser agreed to the entry of a Final Judgment of Injunction for Protection Against Domestic Violence until further order of the court. We encouraged Rosa to apply for victim's compensation to obtain financial aid for her medical bills and worked with her victim advocate to complete the application. Rosa was able to have her medical bills covered. Rosa's abuser was sentenced for the aggravated battery. CCLA secured a Final Judgment of Paternity with Rosa retaining sole parental responsibility and 100% time-sharing with the minor child.

At CCLA, we understand that holistic legal assistance can stabilize a victim and reduce the possibility of returning to an abuser. We assisted Rosa as she obtained food assistance benefits for her citizen child and immigration assistance. We represented Rosa for her Petition for U Nonimmigrant Status as a victim of crime. We filed her Petition and Rosa was able to obtain a temporary driver's license and work authorization. **Rosa's case is truly a testament to the benefit of holistic legal services for victims of crime, especially victims of domestic and intimate partner violence.**

IMPACT: Advocacy

In Broward County over 360,000 people live at or below the poverty line, many of them children and seniors. **The Economic Advocacy and Community Health (EACH) program is dedicated to ensuring their economic status is not a barrier to obtaining benefits that provide for their basic human needs.** Through active legal advocacy, the EACH team assists clients in obtaining benefits that include SNAP (Supplemental Nutrition Assistance Program), Medical Assistance (Medicaid, Medicare) SSI (Supplemental Security Income), Social Security, and TANF (Temporary Assistance for Needy Families). **By providing individuals and families access to these programs, CCLA contributes our community's stability.**

Client Impact: Advocating for Eve's Social Security




Eve has struggled with depression and PTSD for over 10 years. Due to past traumatic events, she endured, and has difficulty completing daily activities, such as going to the grocery store. Eve tried applying for Social Security disability benefits multiple times on her own, even attending a hearing with an Administrative Law Judge (ALJ).

However, each time, she was denied. After submitting another new application in January 2021, Eve contacted CCLA for help.

A CCLA attorney worked with Eve throughout her case to develop strong evidence and we represented her at her hearing. When Eve's psychologist agreed to testify at her hearing, the attorney worked with the psychologist to help him prepare his testimony. At the hearing, Eve's psychologist was able to explain Eve's limitations due to her mental health conditions, and the ALJ commented on how helpful the psychologist's testimony was. This time, with CCLA's representation, the ALJ approved Eve's case! After fighting to get SSI benefits for almost 10 years, Eve was so grateful that CCLA's representation finally allowed her to get her benefits.

IMPACT: Stable Housing for Seniors

For low-income seniors, stable housing is essential for maintaining their overall well-being and quality of life, providing a sense of security and comfort in their later years.

Many face challenges that can jeopardize their housing and threaten that sense of safety. CCLA's Senior Law project attorneys assist individuals age 60 and older who are facing eviction, foreclosure, or are living in unsafe housing conditions. Funded in part by The Jim Moran Foundation, the **CCLA Senior Law Project is dedicated to protecting housing rights and preserving the stability of senior residents across our region.**

Client Impact: Fighting a Wrongful Eviction



Mateo, a hardworking senior who emigrated from Peru a decade ago, sought a better life in the United States. In Peru, he was a high-level government accountant, but in pursuit of the American Dream, Mateo adapted to his new life, working diligently here cleaning trucks. His efforts enabled him to achieve a significant milestone: purchasing his own mobile home. Throughout this time,

Mateo was a model resident of his mobile home park, consistently paying rent on time and never having an issue with Park Management. However, in 2023, Mateo's peaceful life took a drastic turn when he confronted a Park employee for speeding in the neighborhood, a concern for the safety of many children in the area. A day after this confrontation, he unexpectedly found an eviction notice on his door. While on paper the Park has a rule that it is for people 55 and over, throughout his entire time at the Park, he'd seen numerous kids living there. His own kids had lived at the Park for years without any issues. Yet, this eviction notice cited a violation of the Park's age policy for having his own children live with him. He'd planned to move out in Spring 2024 to take a new job elsewhere but had no means to move before then. He was concerned that he, his wife, and two young children would be homeless.

The team at CCLA stepped in to defend Mateo. CCLA attorneys made a Public Records Request which revealed over 20 children were registered for school with the Park's address and there was a school bus stop in the neighborhood. This evidence clearly indicated that the Park was not uniformly applying the age rule and was treating Mateo unfairly. As CCLA prepared for the deposition of the Park Manager to probe this discriminatory enforcement, Mateo proposed a pragmatic solution: a settlement allowing him to stay until Spring 2024, aligning with his plans for a job-related move.

The Park agreed to Mateo's terms, leading to a settlement and dismissal of the eviction case. This settlement secured Mateo's right to stay in his home and continue their lives according to their plan.

IMPACT: Human Trafficking

Florida ranks 3rd in the country for human trafficking and Broward County ranks second highest in Florida for reported human trafficking. Upon arrival at Fort Lauderdale International Airport, visitors receive a welcome recording warning them to be aware of this. **As an award-winning program, Coast to Coast Legal Aid of South Florida's (CCLA) Anti Human Trafficking Program provides comprehensive, free, trauma-informed legal services to survivors of human trafficking living in Broward County.** Through this approach, survivors only need to tell their story once; they work with one attorney on multiple legal problems related to their victimization. We provide holistic legal services for survivors' legal issues including: expungements, T-Visa applications, civil injunctions for protection, divorces, name changes, paternity actions, and enforcement of victims' rights in the criminal cases against their traffickers.

Client Impact: Human Trafficking Victim Has Her Record Cleared Fighting a Wrongful Eviction



For nearly ten years, Jessica was the victim of sex trafficking. She survived trafficking, torture, severe punishments, threats, physical emotional and mental abuse, and extreme traumas. Throughout her victimization, Jessica was forced to commit criminal acts for her trafficker. If she refused, Jessica was beaten and tortured. Because of the abuse and coercion, she would eventually do as she was

instructed. On multiple occasions she was arrested for these crimes, resulting in a criminal record that spanned several years.

She spent years overcoming the horrors she endured. She bravely assisted prosecutors in the prosecution of the trafficker. Throughout this time, she began to heal and move forward. Jessica's resilience and strength would not be defeated by her past victimization. Jessica now has a beautiful family and lives in a safe home. However, her criminal record continued to haunt and prohibit her from fully moving on and starting the next chapter in her life. Jessica came to Coast to Coast Legal Aid of South Florida to seek legal assistance with expunging her criminal record. With the assistance of our specialized human trafficking attorney, Jessica was able to expunge her criminal record. She is thrilled and relieved with the results of her case. She is now applying to colleges to pursue a career helping others.

IMPACT: Mobile Justice Squad



Four years ago, Coast to Coast Legal Aid of South Florida launched its **Mobile Justice Squad (MJS)**. MJS provides free mobile legal services to seniors 60 and older who are homebound, isolated, disabled or face challenges with transportation.

The Mobile Justice Van provides a full range of legal services in areas that include health and public benefits, housing and foreclosure defense, domestic violence, financial exploitation and consumer matters. It is, in effect, a mobile working office for CCLA's attorneys to provide on-the-go legal advocacy.

The Mobile Justice Squad project is funded by The Jim Moran Foundation and the American Bar Endowment (ABE).




