Coast to Coast Legal Aid of South Florida provides free civil legal services to eligible people.

Mission

CCLA's mission is to provide equal access to justice to underserved communities through quality and innovative free civil legal aid.

How it Works

Coast to Coast Legal Aid of South Florida (CCLA) provides free civil legal services for residents of Broward and Collier Counties who qualify for services. CCLA also provides free civil legal services through its pro bono programs Broward Lawyers Care and Collier Lawyers Care.

Financial eligibility is based upon the income and assets of individuals in a household. In most cases, the income of a household does not exceed 200% of the federal poverty level, many under 125% of the federal poverty level. Depending on the active grants, there may be different eligibility guidelines. Eligibility for services is also based upon whether a legal problem falls within CCLA's service area, priorities and practice areas.

CCLA intake specialists will assist applicants to complete an application and determine eligibility for services. Applicants may call 954-736-2400 Monday to Friday from 9AM to 3PM or complete an online application 24/7.
