

# FREE LEGAL HELP FOR VICTIMS OF DOMESTIC VIOLENCE

Coast to Coast Legal Aid of South Florida provides holistic **legal services to victims of intimate partner violence, domestic violence, sexual violence, elder abuse, dating violence, stalking, and human trafficking.** We will perform a “legal check-up” and may be able to help you with any number of civil legal needs such as an Injunction for Protection, divorce, paternity, housing, benefits, or enforcement of your victim’s rights in a criminal proceeding. You may be required to meet certain income guidelines.

**If you are eligible, the services are FREE.**
