The **Survivors of Human Trafficking Legal Program** provides comprehensive, free civil legal services to survivors of human trafficking living in Broward County.

The Survivors of Human Trafficking Program is a trauma-informed, holistic legal program. Under this approach, survivors will not have to relive and recount their experiences multiple times with multiple attorneys in order to seek relief for various legal problems - survivors will work with one attorney and one paralegal for their multiple legal issues.
