Legal Aid offers holistic and comprehensive services to persons living with HIV. These services are designed to provide peace of mind and enable individuals to focus on their primary struggle, fighting the virus and staying well.

Stable housing is crucial for the overall health and well being of persons living with HIV. Often times there are underlying factors inhibiting access to stable housing. Legal Aid attorneys work with clients to ensure safe and secure housing, while also addressing any underlying legal issues that could threaten the stability of that housing. The **HIV Law Project** is the only Ryan White-funded legal advocacy program for low income residents of Broward County living with HIV.

Individuals seeking legal assistance must be current with their Ryan White Part-A Eligibility as determined by the Centralized Intake and Eligibility Determination (CIED) program.

To determine your eligibility for Ryan White services in Broward County, call **954.566.1417**.

The **Housing Opportunities for Persons with AIDS** (HOPWA) program is the only federal program dedicated to the housing needs of people living with HIV/AIDS. The Housing & Urban Development Department (HUD) provides legal aid with funding to assist low-income persons medically diagnosed with HIV/AIDS. Gilead Sciences provides funding to serve the HIV population over 50 years of age.

Individuals seeking HOPWA assistance need active and open enrollment through a HOPWA housing case management partner.
